Date: Sunday, February 7, 2010
Location: Brighton High School, Brighton, MI
Entries: \$25 if postmarked by Feb. 1 or \$35 after Feb. 1

All relays will be deck entered. Swimmers may swim a maximum of 4 individual events and 2 relays. Only pre-entries will be accepted for the 1500m and 400m freestyle. Relay cards are due 30 minutes prior to each relay event. You must be entered in the meet to swim on a relay team.

FINA rules apply to SCM meets. Your age on 12/31/2010 determines your age group.

Deck registration closes 9:30 am no exceptions.

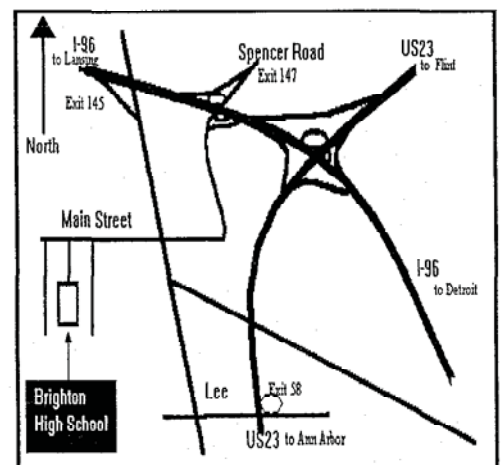
- Session II Warm up 10:00-10:30; Warmup/warmdown area available at all times.
 Event #2 (200m Medley Relay) begins 10:30 am

- Eligibility:** Only current 2010 USMS members will be allowed to compete. USMS registrations will not be offered at the door. See Michigan Masters website for registration information.

- Meet Snacks:** Provided by FAST and are included in your entry fee.

- Directions:** Brighton High School is on Sage Street. Sage is off Main Street past 7th, about one mile west of Grand River.

- **From Lansing:** 1-96 south to Grand River (Exit 145); Grand River south to Main Street; turn right onto Main Street.
- **From Ann Arbor:** US-23 north to Lee Road (Exit 58); Lee Road west to Rickett Road; turn right and merge onto Grand River north; Grand River to Main Street; turn left.
- **From Flint:** US-23 south to 1-96 west, then follow Detroit directions below.
- **From Detroit:** 1-96 west to Spencer Road (Exit 147); turn right onto Spencer Road, traveling west, wind around numerous curves and go past Grand River; Spencer Road turns into Main Street.
